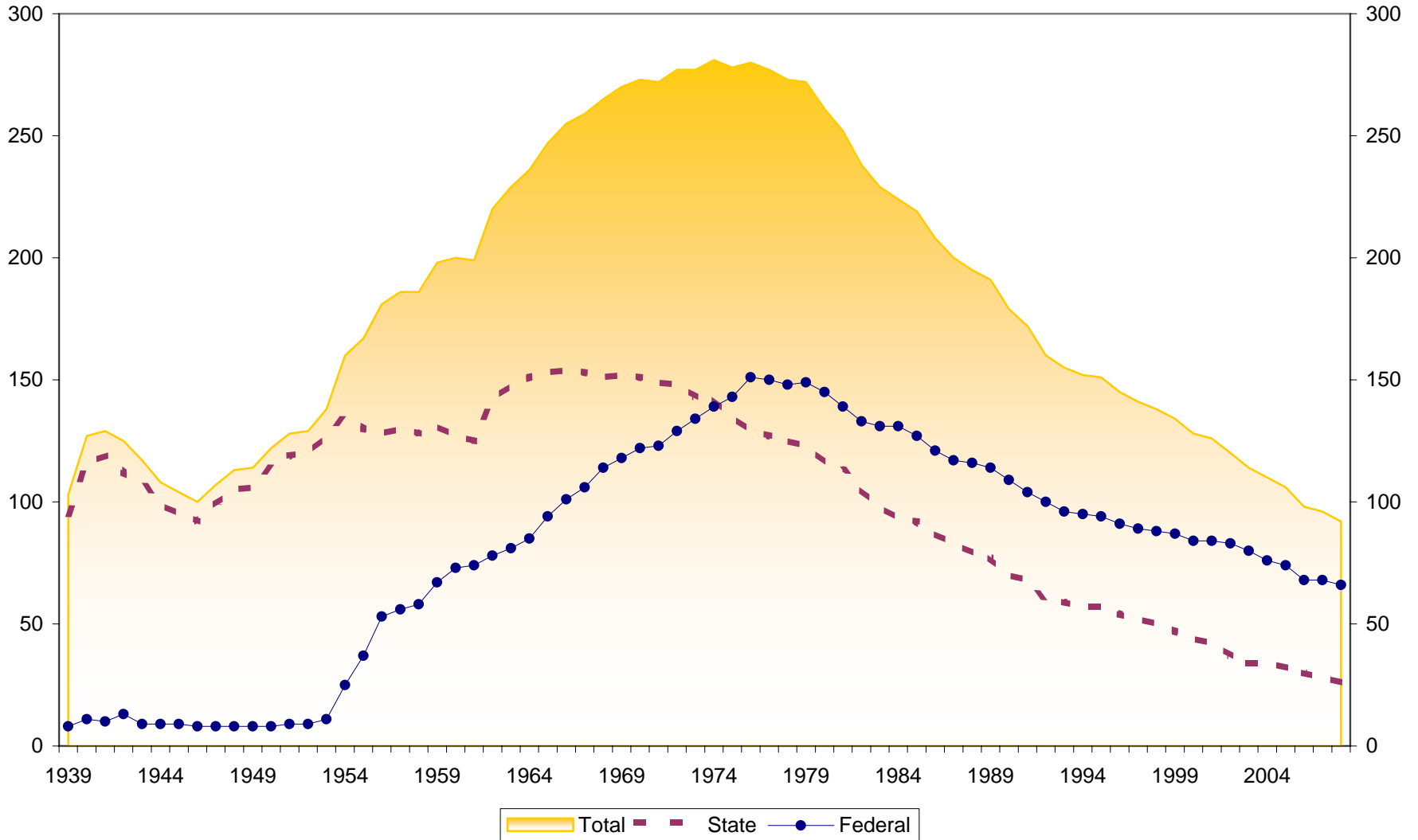

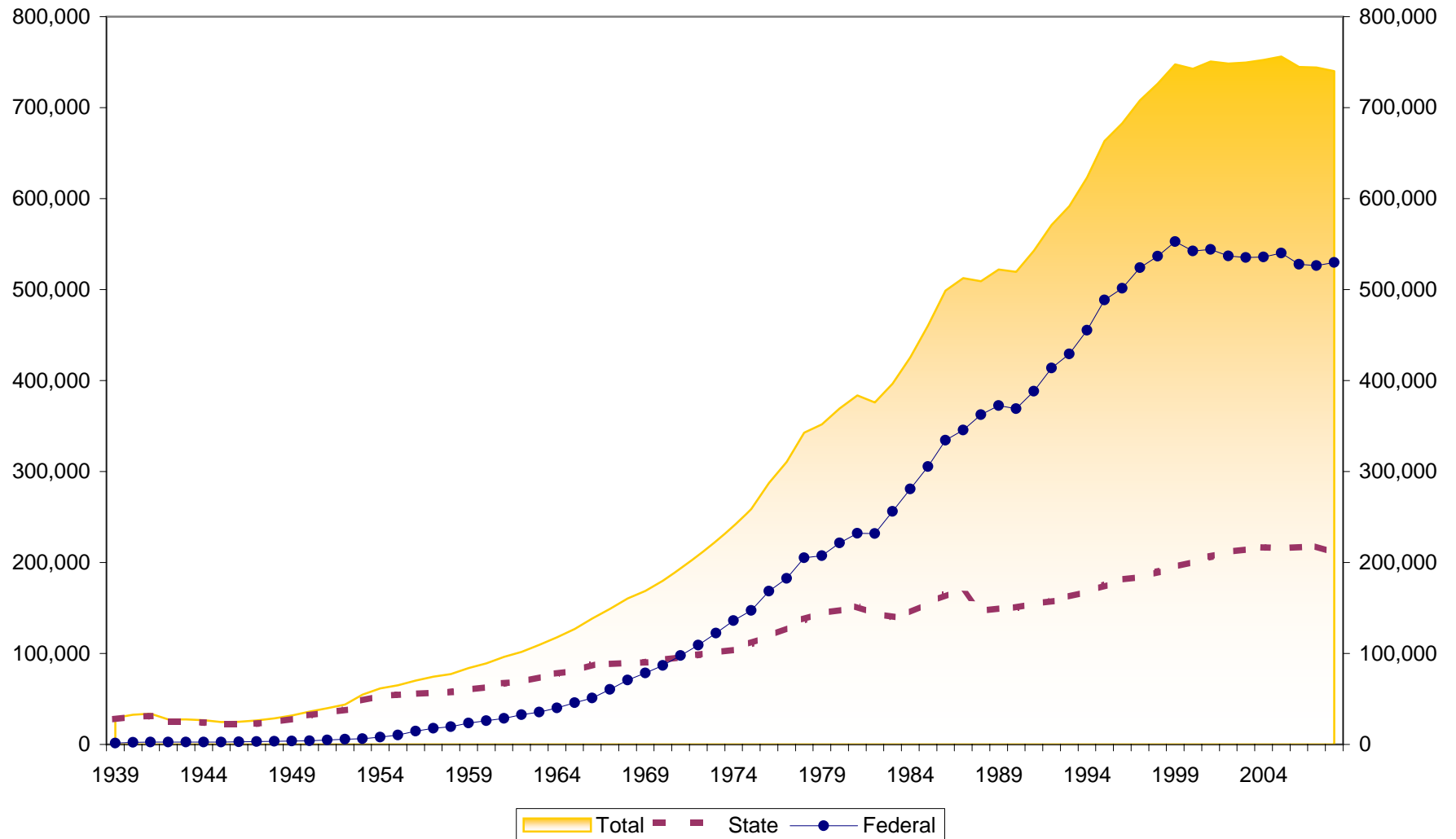

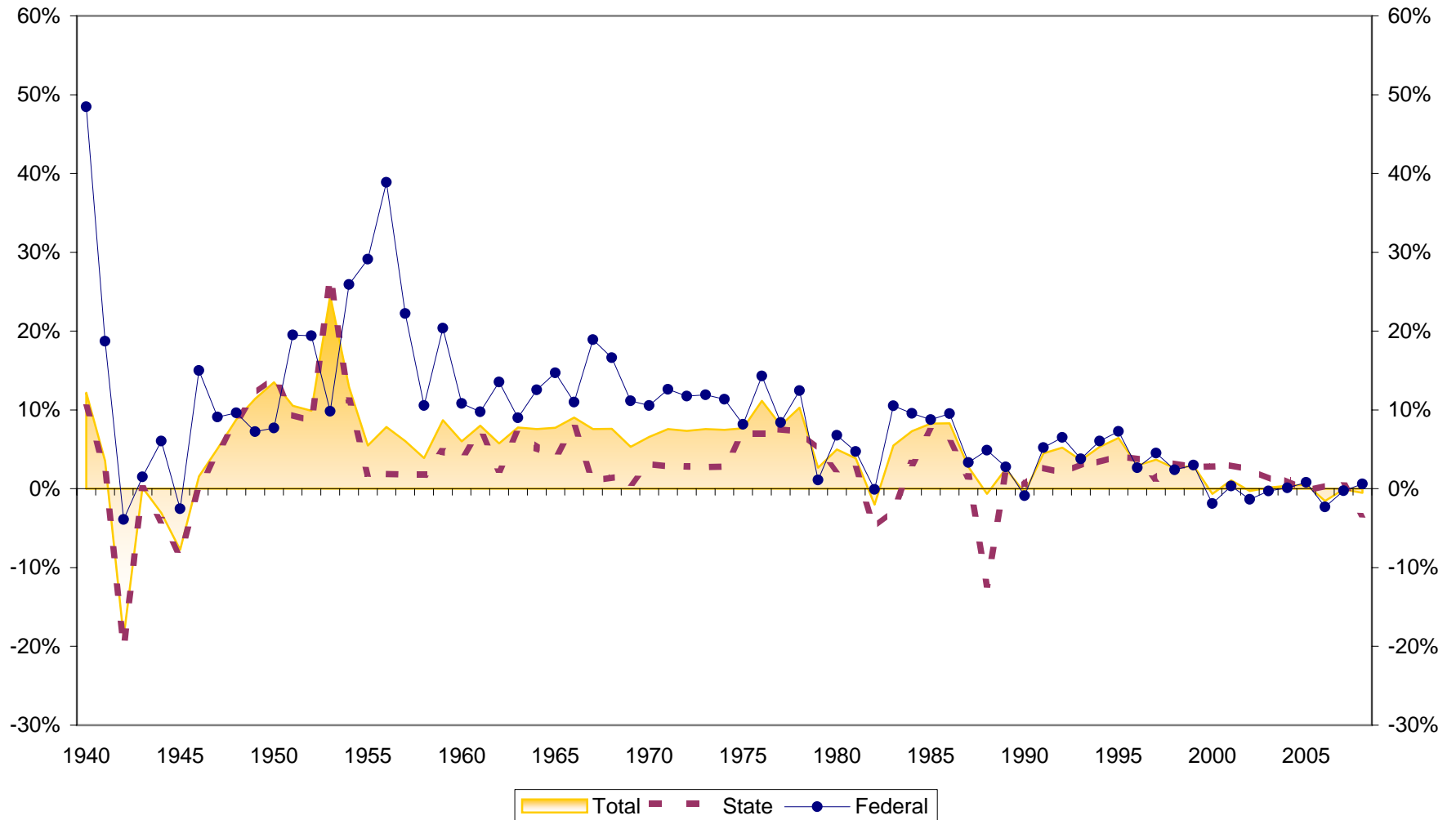
Number of Kentucky Credit Unions 1939-2008



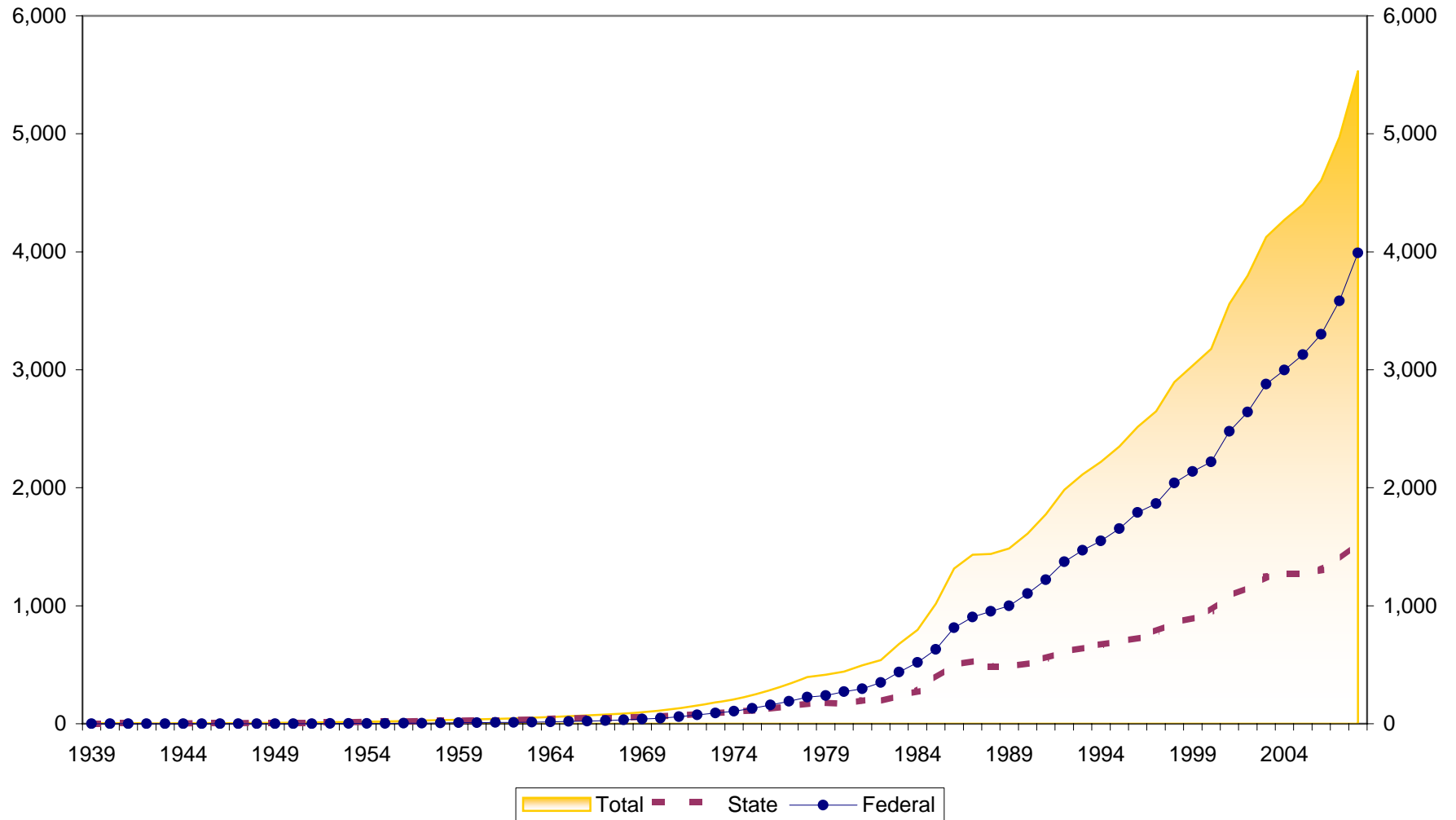
Number of Members at Kentucky Credit Unions 1939-2008



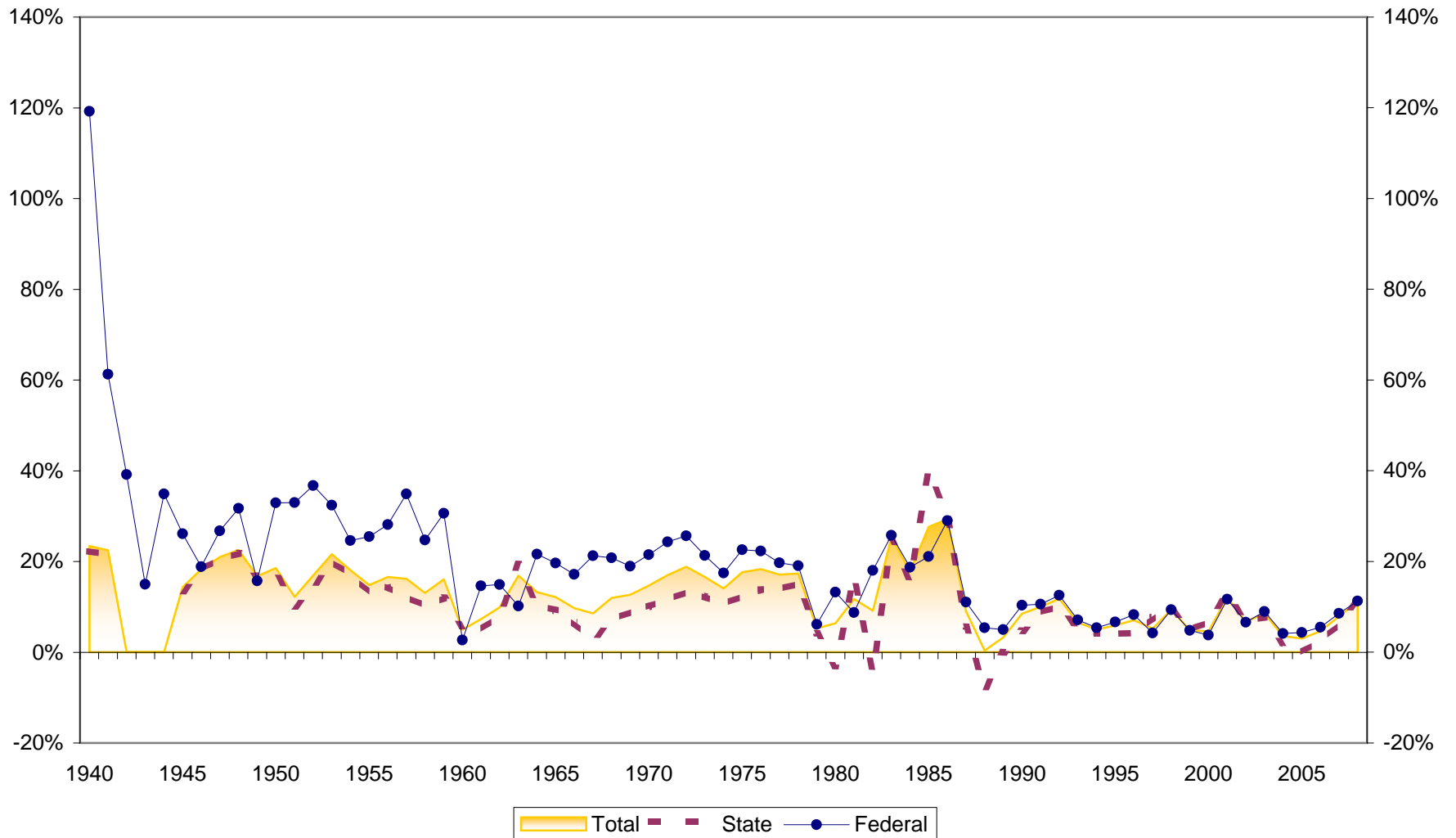
Membership Growth at Kentucky Credit Unions 1940-2008



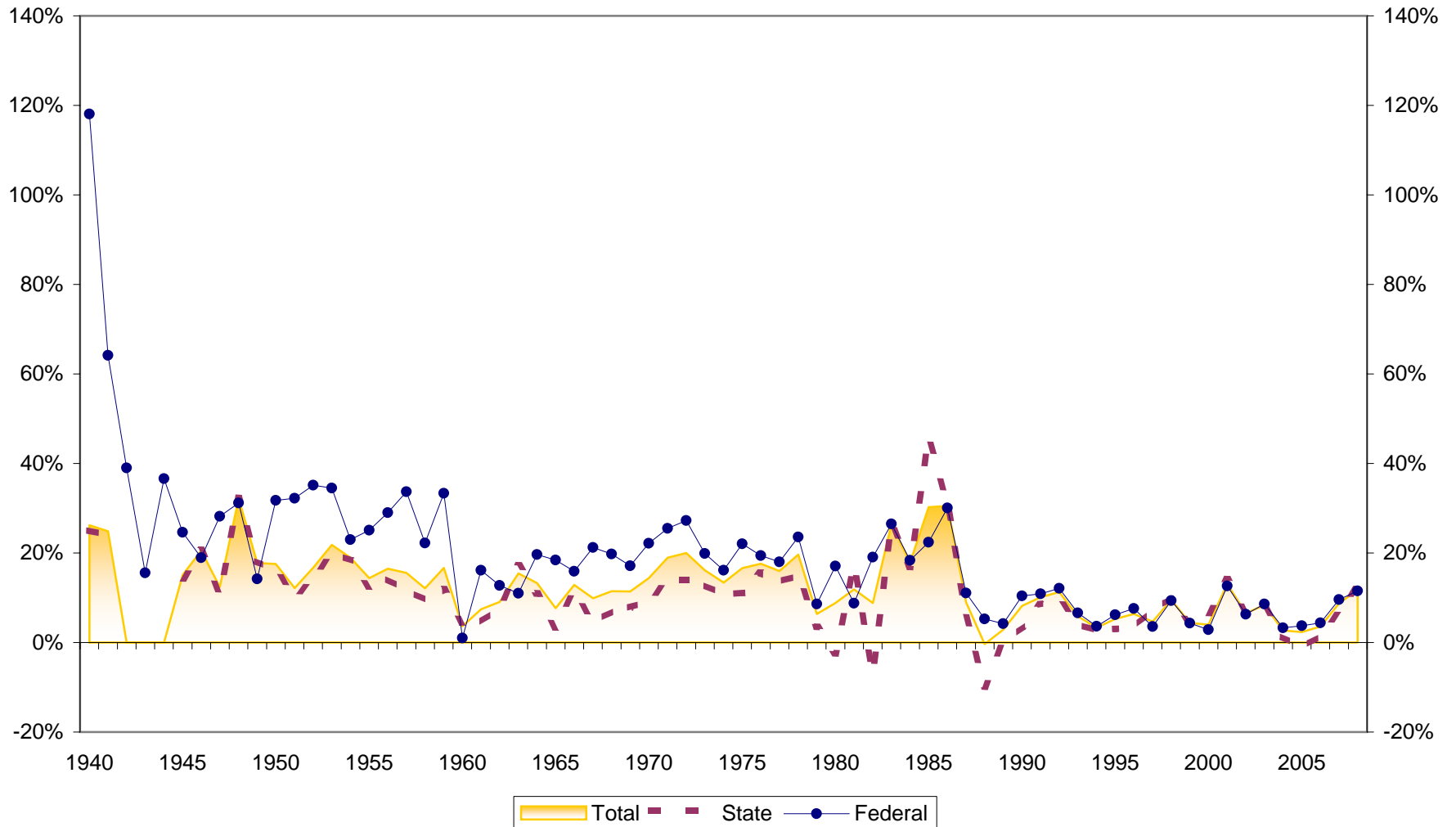
Assets at Kentucky Credit Unions (in \$Millions) 1939-2008



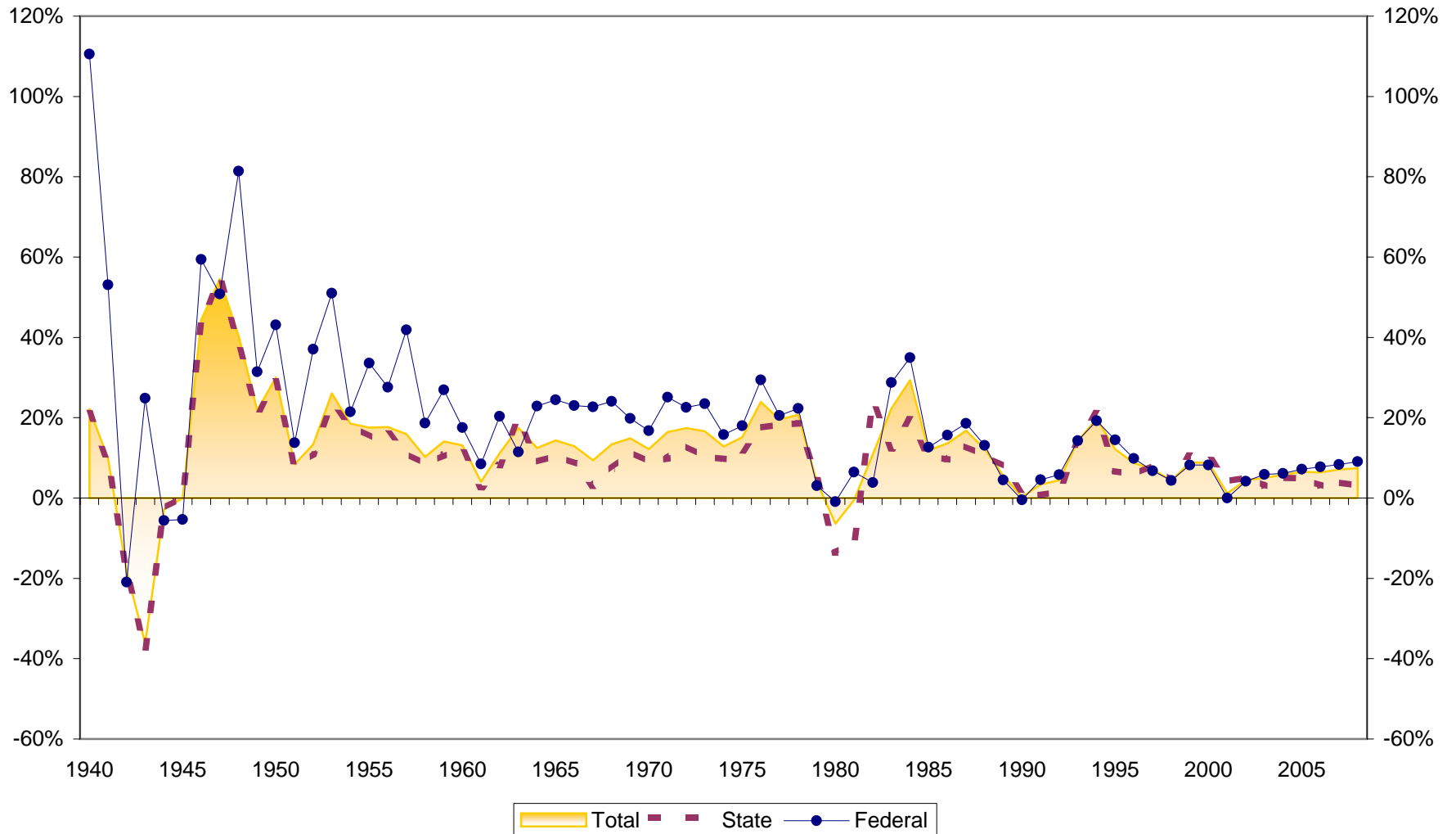
Asset Growth at Kentucky Credit Unions 1940-2008



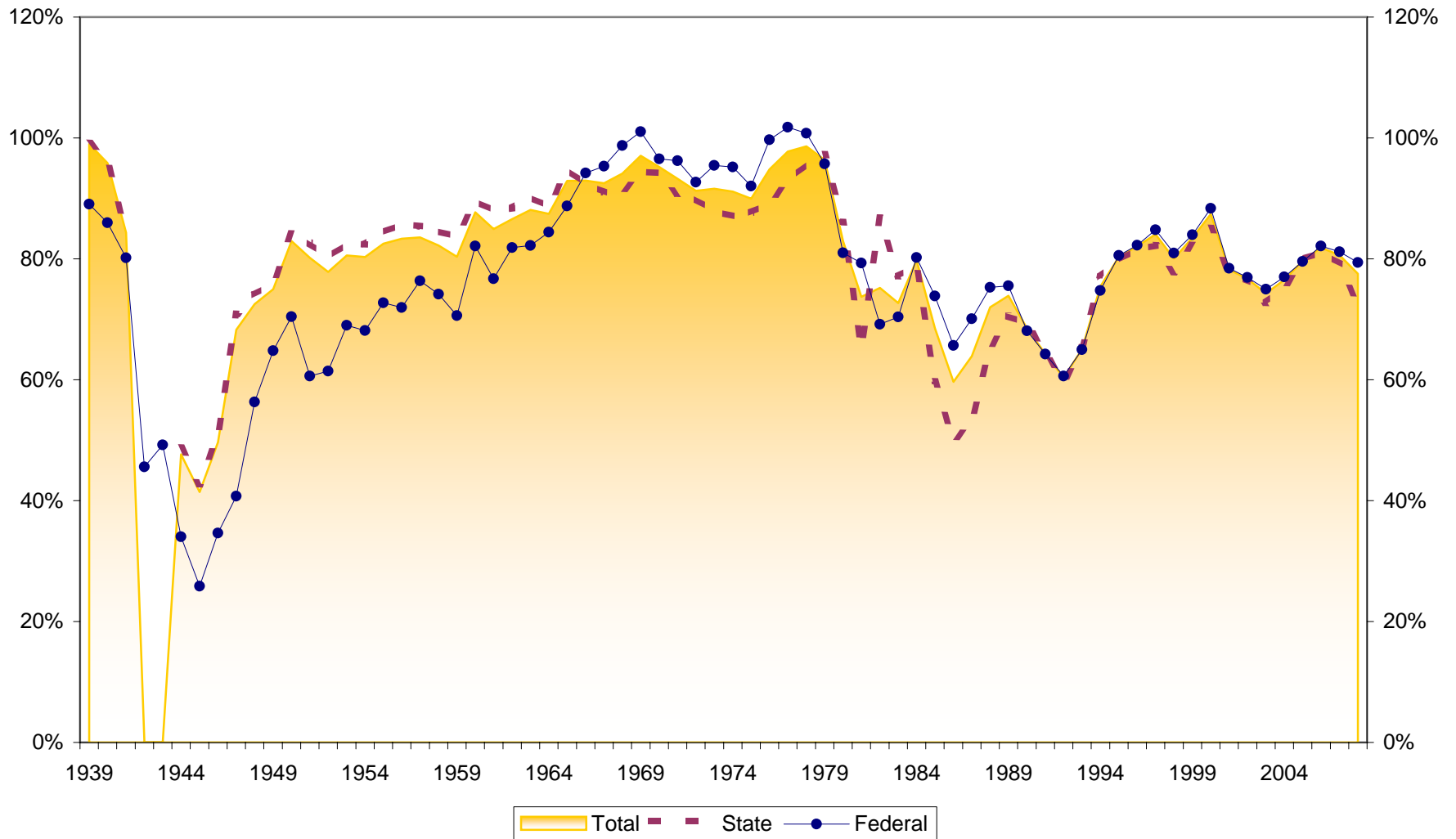
Savings Growth at Kentucky Credit Unions 1940-2008



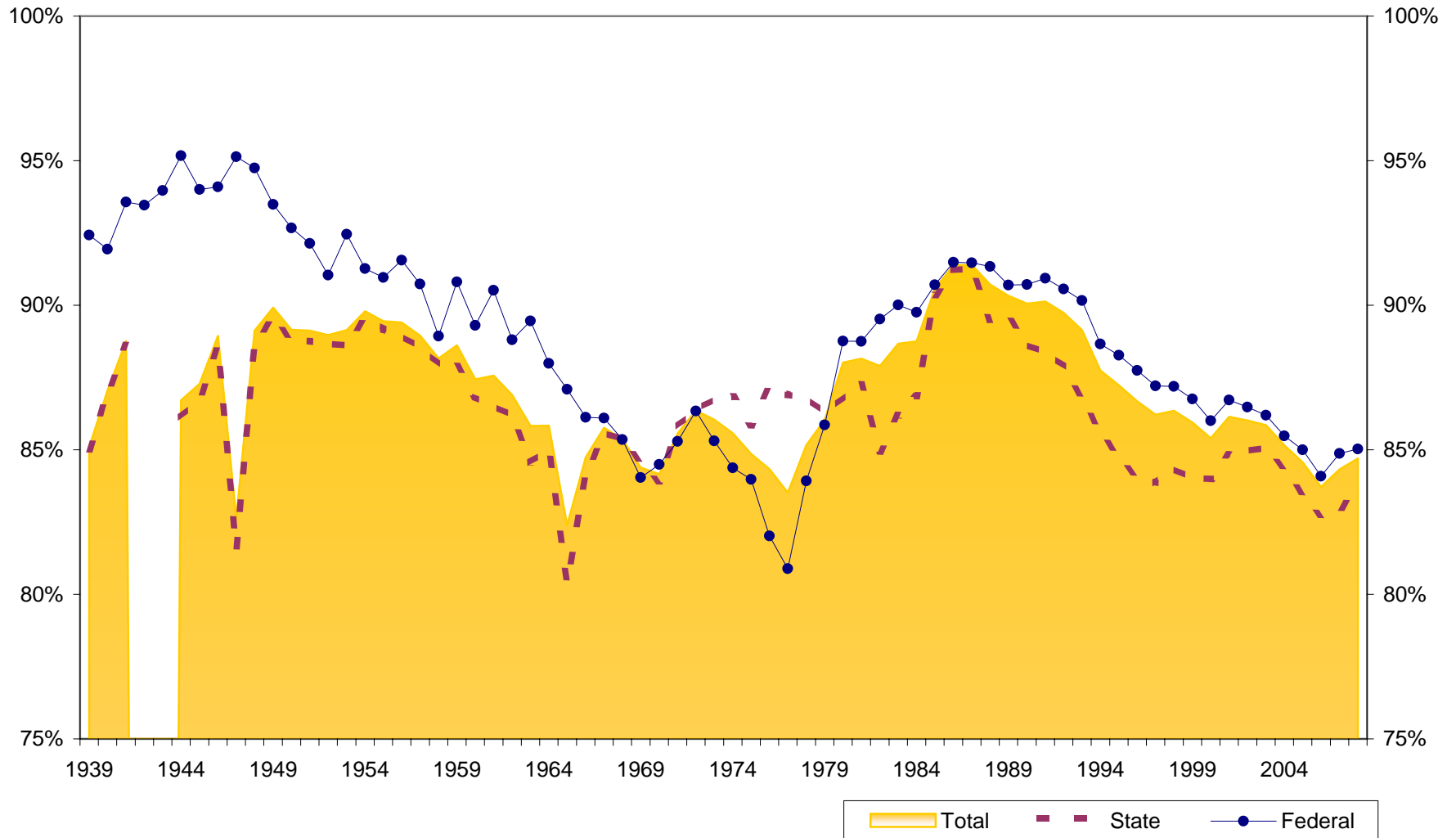
Loan Growth at Kentucky Credit Unions 1940-2008



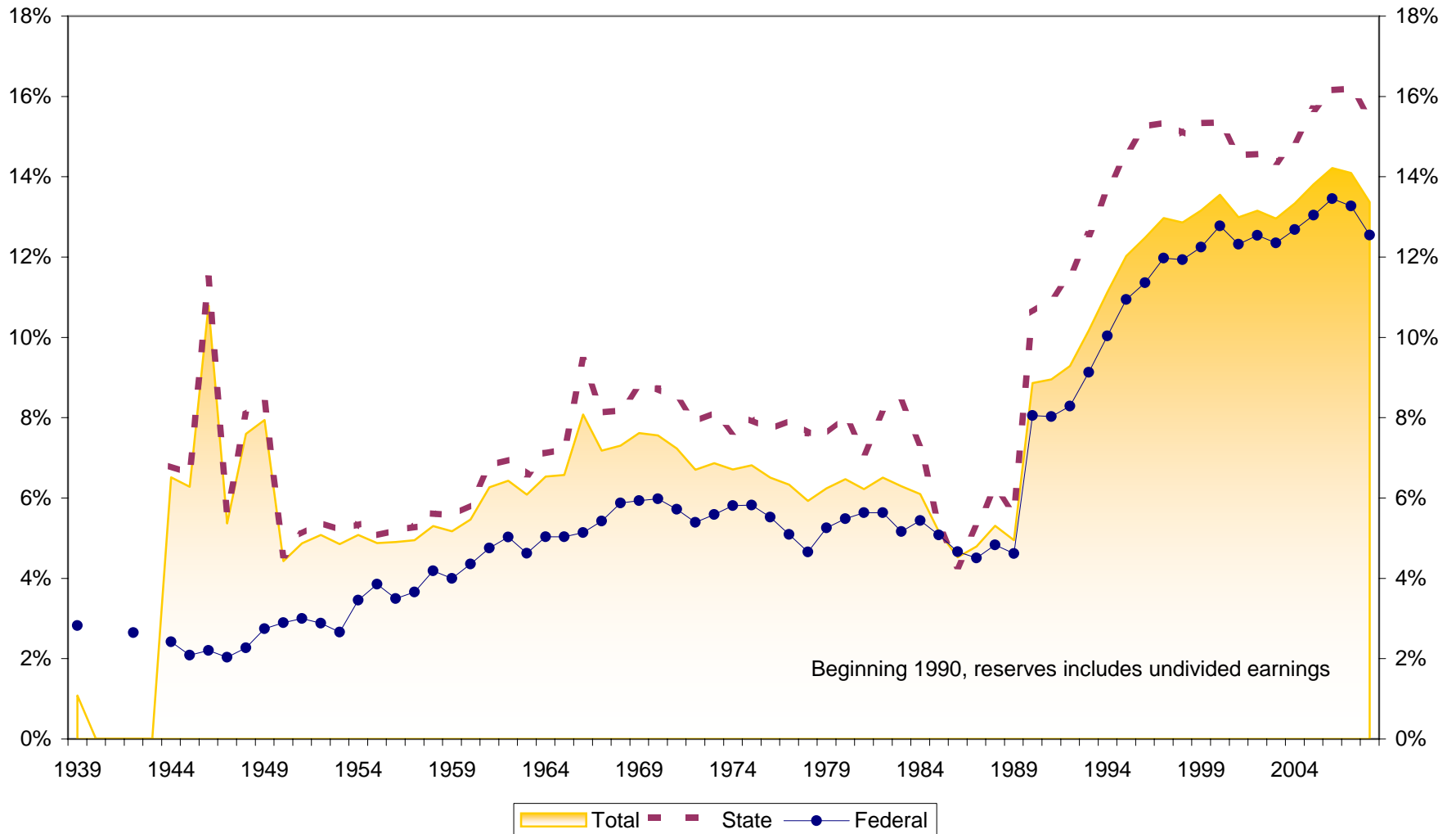
Loans to Savings Ratio at Kentucky Credit Unions 1940-2008



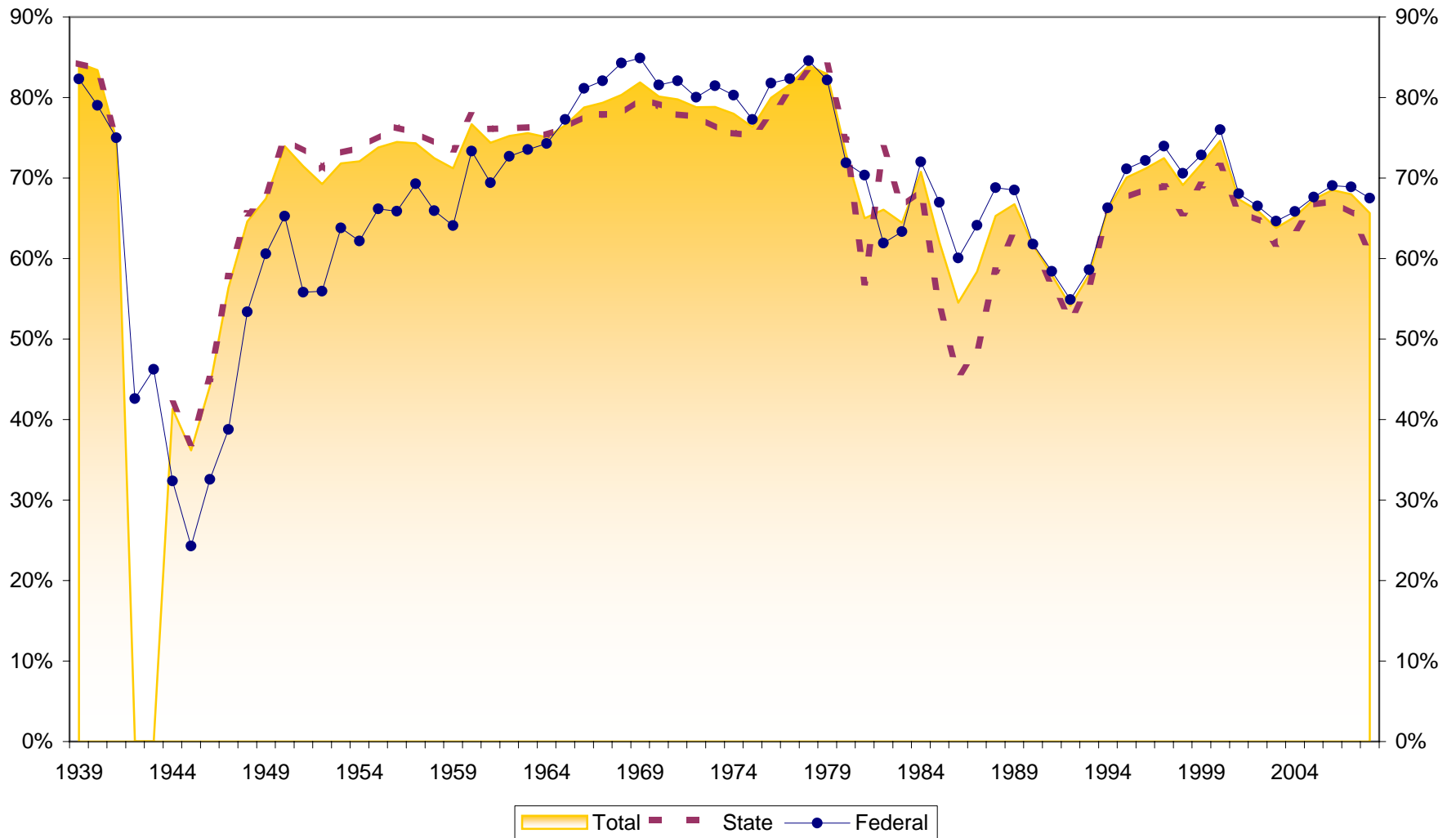
Savings to Assets at Kentucky Credit Unions 1940-2008
